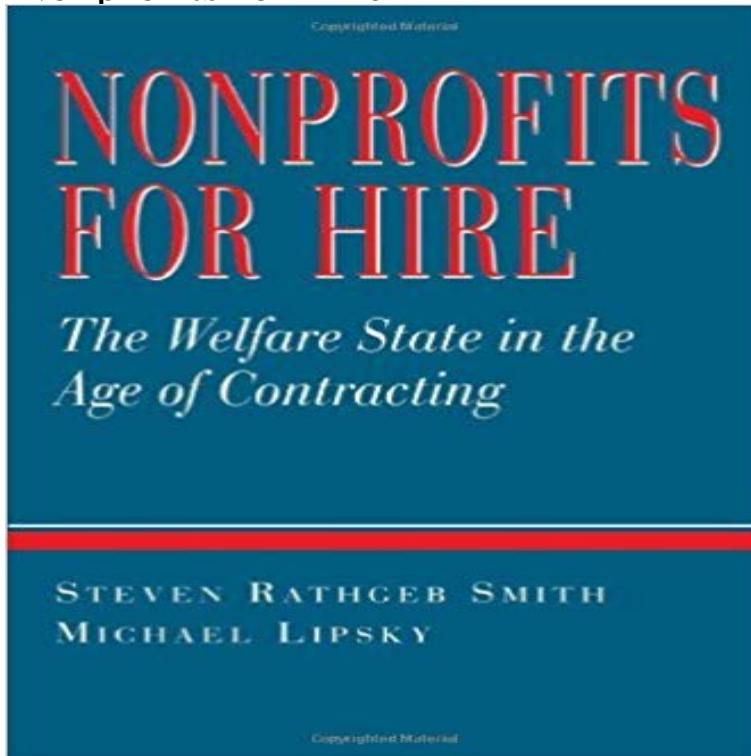


Nonprofits for Hire
